Suggested improvements:

1. Terms such as "instruction-tuned LLMs" and "RAG framework" are introduced in the discussion without adequate explanation.

Please consider adding brief definitions or footnotes for clarity.

- 2. Tables II and III could benefit from clearer visual formatting—Align the text in the table both horizontally and vertically
- 3. Figure captions (e.g., Fig. 13) can be made more concise and informative.
- 4. A few sentences still contain awkward phrasing (e.g., "each factor is assessed to ensure maximum effectiveness and positive user

experience" could be refined to "...to ensure a positive and effective user experience").

- 5. Consider tightening the sentence structure in the Discussion section, especially to reduce overuse of passive voice.
- 6. While the manuscript proposes multilingual and scalable adaptations, it would be helpful to briefly mention specific strategies (e.g.,

transformer-based OCR models or lightweight models for mobile use) to strengthen future work.
